On 11-13-18 at approximately 4:11 pm. I, Sergeant J. Alexander received a call from Stephenville dispatcher in reference to a student by the name Hunter Durham was wanting to [REDACTED] The dispatcher said that the student live at Integrity Hall on the second floor.

The caller (Lauran Dowdy) told the dispatcher that Hunter had a 9mm hand gun and he was on his way back to Stephenville.

Upon arrival at Integrity hall I made contact with Juana Moncada the resident coordinator of that dorm. In her office was a friend of Hunter Durham by the name as Ryan Halford. Ryan had on his phone a screen shot of a message from Hunter stating that he lost his girl of his dreams and he was failing his classes. He also said that he had bought a 9mm rifle and [REDACTED]

While I was there at Integrity Hall.

Stephenville dispatch advised that the reporting person (Lauran Dowdy) said that Hunter was Granbury at Parts and Sports Center and the he had just bought an AR-15.

The clerk told Stephenville Dispatch that would stalled him long enough for Granbury police to arrive.

Chief Welch said that he talked to officer Kemp with Granbury PD. Officer Kemp told Chief Welch that he patted Hunter Durham down and he didn't find any weapons on him and released him to leave. Officer Kemp said that he did not search his vehicle.

We ask Juana if she would do an administrative search for weapons while we was in the room.

At this time officer Jackson and I went with Juana Moncada to room 2004D which is located in Integrity.

Juana Moncada knocked on the door several times. As she started keying in Hunters roommate (Brandon Alexander) met Juana at the door.

Juana asked Brandon if he had talked to Hunter today and he said that texted Hunter but he got no response from him.

Brandon said that Hunter has been posting things on his snap chat story line. Juana opened Hunters room and she was looking around while we were in the room.

On Tuesday November 13, 2018 at approximately 5:50pm I was notified by Chief Welch of an ongoing welfare concern that the days shift officers had been working on. He briefed me on the call and the concern about the suspect (Durham) bringing a gun on campus and trying to [REDACTED] or others. Suspect (Durham) had a scheduled class that started at 6:30pm in the nursing building. I instructed officers Schloeman #362 and Loya #349 to be in the area. We were all provided a picture of the suspect (Durham). When the suspect did not show up for his 6:30 class we began to check other areas of campus. Officer Schloeman stayed in the classroom, Officer Loya began checking parking lots and I went to Integrity Hall, where he lives, to inform the RLs to call us if they saw him.

Suspect Durham's mother contacted Officer Loya by phone and relayed information that suspect Durham had bought a gun and was on campus. We were able to obtain his vehicle information, silver/grey Nissan Titan truck, and began a search for the truck.

Officer Loya was walking through the P29 parking lot (1560 W. Shirley) when he saw a truck matching the description of suspect Durham's truck. The truck was backed into a parking spot, was running, and windows were up. Officer Loya approached the truck and as he did, he noticed the person in the driver seat was looking down at a rifle that was positioned between his legs with the barrel pointed down. Suspect Durham was preparing to load the 30 round magazine with 5.56 ammo. Officer Loya got suspect Durham's attention and told him to roll down the driver side window. As suspect Durham complied, Officer Loya ordered him to put his hands on the steering wheel. Officer Loya then grabbed suspect Durham's left wrist and opened the truck door. Maintaining control of suspect Durham, Officer Loya grabbed the rifle and threw it clear of the truck. He then pulled suspect Durham out of the truck and put him on the ground. Officer Loya handcuffed suspect Durham and notified all other officers, via portable radio, that he had the suspect in custody (7:01pm).

I arrived on scene and instructed Officer Loya and Schloeman to transport suspect Durham to the hospital on [REDACTED]

I took possession of the Anderson Manufacturing AM-15 rifle. It had been purchased earlier in

the day from Marksmen Firearms in Granbury Texas, according to the receipt found in his pocket. The invoice (112036) showed the rifle was purchased on 11/13/2018 at 5:37pm. The receipt also showed the purchase of 2 boxes of PPU 5.56 ammo. The rifle was seized for safekeeping, tagged, and placed into the TSU PD Property room.

Located sitting on the center console of the truck, between the front driver seat and the front passenger seat were two full boxes (20 rounds per box) of PPU 5.56x45mm ammunition. Also sitting on the center console was a 30 round magazine for the Anderson AM-15 rifle. These items were seized for safekeeping, tagged, and placed into the TSU PD Property room.

Upon further inspection of the truck I located three knives, a black Kershaw lock-blade pocket knife, a stainless Maxam lock-blade pocket knife, and a black Kershaw "speed safe" lock-blade pocket knife. These items were seized for safekeeping, tagged, and placed into the TSU PD Property room.

Suspect Durham's keys and cell phone were released to his sister by Asst. Chief Alcon. Chief Welch also arrived at the scene and informed me that he was going to contact Dr. Faulkner.

Officers J. Schloeman # 362, C. Loya # 349, Sgt. C. Gilliland # 353, were in full uniform, and Chief M. Welch # 340, assistant Chief A. Allcon # 341 were in plain clothes at the time this contact was made.

On 11/13/2018 at approximately 18:55 hours, I was assigned to assist on a welfare concern call, in reference to a possible armed student that may harm [REDACTED] or someone else. I and other officers involved in attempting to locate the suspect ( Durham, Hunter ) received information from witness ( Durham, Tammie ) his mother, that he was possibly on campus in a parking-lot near Legends Hall.

I and other officers were given a description of a possible vehicle he was occupying, and Officer Loya who approached that area on foot made contact with suspect in the described vehicle in P-29 lot near Legends Hall.

I made the scene at approximately 19:03 hours and observed suspect ( Durham ) hand-cuffed and prone on the ground. Officer Loya advised me that he had taken the suspect ( Durham ) into custody. Officer Loya then assisted Suspect ( Durham ) to his feet and placed the hand-cuffed suspect ( Durham ) into my marked police unit.

I observed several items on the ground beside where the suspect ( Durham ) had been hand-cuffed. There was a cell phone, billfold, two black gloves and a paper receipt. The billfold contained identification belonging to the suspect, and the cell phone was identified by suspect sister, ( Durham, Hailey ) as belonging to suspect. The paper receipt contained printed information on the purchase of the assault style weapon that was recovered at the scene. This receipt was taken into my custody and later transported to 895 N. Harbin, Tarleton Police Dept. and marked and tagged as evidence and placed in the evidence locker.

Suspect ( Durham ) had demonstrated that he was a danger [REDACTED] to others by his actions and his articulation of [REDACTED]. Suspect ( Durham ) also had the means to carry out the threat against [REDACTED] others that may have been nearby or had tried to intervene. Due to his immediate access to weapons there was no time to procure a

~~warrant before Officer Loya took him into custody. I transported suspect (Durham) to~~

Stephenville Harris Methodist Hospital and completed an [REDACTED]

[REDACTED] I activated the police units on-board video camera while in transport. Officer Loya # 349 followed me to the hospital and guarded the suspect until which time suspect could be evaluated by counseling services. Suspect (Durham) was released to the custody of hospital and counseling services personnel uninjured and in good physical condition.

On 11/13/2018 at approximately 19:40 hours, I spoke with Witness (Durham, Hailey) at the hospital who is the sister of suspect and she advised me that suspect (Durham) had been depressed lately over the break-up with his girlfriend. Witness (Durham, Hailey) stated that she learned from her mother witness (Durham, Tammie) and witness (Dowdy) his x-girlfriend that he had been making threats against [REDACTED]. Witness (Durham, Hailey) advised she obtained suspects location on the Tarleton State Campus through a "snap chat" feature that gives the location of friends and family members. She immediately relayed that information to police, and Officer Loya was able to locate the armed suspect parked in his vehicle in the P-29 parking-lot at that time.

On 11/13/2018 at 20:15 hours, while I was in the emergency room, I spoke with witness (Durham, Tammie) mother of suspect. Mrs. Durham advised that on October 21st, 2018 that suspect had [REDACTED], and on November 5th, 2018 he was involved in a single car roll-over accident in which he was operating the vehicle. On this date 11/13/2018 she received information through a phone call that suspect was making threats [REDACTED] and making other threats about [REDACTED]. Witness (Durham, Tammie) stated that suspect had made statements that he would be [REDACTED]. She further advised me that she was advised by witness (Dowdy) that suspect stated to her that he was going to [REDACTED].

On 11/13/2018 at 20:36 hours, I spoke on the phone with witness (Dowdy) x-girlfriend of suspect. She advised me that on this date 11/13/2018 and on recent previous dates the suspect had made numerous threats [REDACTED] and stated he was going to [REDACTED]. Witness (Dowdy) stated that on this date 11/13/2018 at 4:17 P.M. he called her and told her he was at a gun store and [REDACTED]. He also stated that [REDACTED]. She stated that at 5:57 P.M. he contacted her back and during that conversation she ask him [REDACTED] and he responded [REDACTED].
